NORTHEAST SECTOR:

Details:

- Fixed site details were cancelled due to flooding.

Crashes:

Notables:

- 07/10 Inspectors assisted state and local agencies with road closures within their patrol areas.



- 07/10 Brighton VT Rte 114. An Inspector stopped and weighed a CMV transporting logs. The CMV was found to be 13,900lbs over its permitted weight limit. An inspection was completed and the company was issued a ticket for the weight violation.



- 07/11 Lowell Vt Rte 58. An Inspector on patrol discovered a sinkhole that had started. The inspector cordoned off the area and stood by until AOT could arrive. The sinkhole turned out to be five feet deep by three feet wide.



- 07/11 Morrisville VT Rte 100. An Inspector stopped a CMV for a moving violation. The CMV was found to be transporting an improperly secured piece of equipment and was placed out of service. Guidance was given to the operator on proper securement.



- 07/12 Waterford VT Rte 18. An Inspector stopped and weighed a four-axle dump truck, The CMV was found to be operating at 12,500lbs over its permitted road limits. A ticket was issued to the company.
- 07/13 Burke VT Rte 114. An Inspector stopped a loaded dump truck. The CMV was weighed and found to be 9,200lbs over its permitted weight limits. An inspection was conducted and the company was issued a ticket for the weight violation.



- 07/13 Burke Vt Rte 114. An Inspector on patrol stopped a CMV for an equipment violation. The operator was found to have a class D operator's license when a class A CDL was required. The CMV was placed OOS for inoperable brake and turn signals as well as having a defective emergency breakaway cable. The carrier was issued a VCVC.



- 07/13 Derby US Rte 5. An Inspector stopped a CMV for equipment and load securement violations. An inspection was completed and the CMV was placed out of service.



- 07/14 US Rte 5 Ryegate. Two CMVs transporting woodchips were stopped and weighed. One was found to be 7,900lbs and the second 8,100lbs over permitted road limits. Tickets were issued to the respective companies.



- 07/14 St Johnsbury US Rte 5. An Inspector on patrol stopped a CMV for a load securement violation. The operator was found to have a class B CDL when a class A CDL was required. The CMV was also displaying Agricultural registration plates. Multiple violations were noted on the inspection and the driver and combination was placed OOS.

Notables:

- 7/13 Cpl. stopped an interstate tractor trailer on I 89 in Colchester for non-conforming hazmat placards. An inspection was conducted, and the vehicle was found to contain bulk and non-bulk hazmat. The trailer was placed out of service for failing to display identification numbers.



- 7/13 Sgt. was called to assist Essex Police with a dump truck in intrastate commerce which was not properly registered, and the operator was not properly credentialed. An inspection was conducted, and the vehicle and driver were placed out of service.



- 7/13 Cpl. stopped an intrastate truck and trailer on Rt. 7 in Colchester for an expired state inspection. The truck and trailer were not registered and were displaying license plates not assigned to those vehicles. The plates were seized, and the vehicles were grounded.



- 7/14 Cpl. stopped an interstate truck hauling a trailer on I 89 in Richmond for an equipment violation. An inspection was conducted, and it was observed 2 out of 8-wheel fasteners were missing on one of the trailer wheels. The trailer was placed out of service for the defect.
